

SAN JUAN ISLANDS VACATION VIDEO Contest Rules

No purchase necessary to enter or win. Contest open to anyone 12 and older. To redeem Grand Prize winner must be 18 years of age or older as of November 1, 2009. Contestants younger than 18 years of age must have parent or legal guardian redeem Grand Prize during the dates specified. Grand Prize must be redeemed during the period November 1, 2009, through May 15, 2010 (unless otherwise specified). Prizes are transferable to an eligible person aged 18 or older (unless otherwise specified). Separate elements may be redeemed at different times but must be used during the aforementioned redeemable dates (unless otherwise specified).

1. TO ENTER: Contest period begins January 1, 2009 and ends October 31, 2009. Video entries must be posted to YouTube as a Video Response to the "Vacation Video Contest San Juan Islands" video at www.youtube.com/vacationvideocontest, or by emailing a link to an existing video that was produced from time spent in the San Juan Islands during the contest entry period to contest@sanjuanislandsTV.com. All entries are subject to an approval process before being accepted into the contest. All approved entries will be posted to the aforementioned "Vacation Video Contest San Juan Islands" video page on YouTube, and embedded or linked to the "San Juan Islands Vacation Video Contest" section on www.sanjuanislandstv.com, and any other interested party websites including but not limited to contest sponsors and promoters, and shall remain public (YouTube video viewing setting) for viewing through December 31, 2010. Entries will be voided if made Private (YouTube video setting) during that period. It is the responsibility of winning contestant to respond to the winning notification within 10 days or Prizes may be awarded to the next winning entry.

2. CONDITIONS: Entries will be void if they are deemed lewd or offensive by the contest sponsors and/or promoters. No profanity or nudity. Comparable rating guide would be similar to but not limited to G and PG-13 MPAA movie rating guidelines. By entering, entrants acknowledge compliance with these official rules including all eligibility requirements. All entries remain personal property of the contestant with the expressed permission for contest sponsors and promoters to utilize the video in any marketing, advertising, or promotional programs and/or materials.

3. CONTEST GUIDELINES: Contestant must create a video or video slide show of a vacation, weekend getaway, wedding or any other time they experienced in the San Juan Islands, including but not limited to Lopez Island, Orcas Island, San Juan Island, Shaw Island, outer islands, uninhabited islands, and State Parks. Videos can be slide shows of still images. Videos must be limited 10-minutes or less in length. Entries will be accepted providing Conditions are met. Winning entry will showcase how much fun it is to visit the San Juan Islands, highlighting any and/or all aspects of the islands (natural beauty, recreational activities, art/culture, dining, lodging, people, etc.). Entrants may submit more than one video. There is no fee for entry.

Individual limitations, specifications, and applicable dates for each gift element is at the discretion of the providing company or entity. Details are available from each company or entity.

First Prize: Winner will receive a family weekend camping trip for four at Canoe Island French Camp. ARV is \$1,000. Transportation to and from Canoe Island is included from any San Juan Islands ferry terminal. Available dates are limited and at the discretion of Canoe Island French Camp.
